Sub: Renewal of Provisional Affiliation for (i) BAMS, and (ii) BHMS courses.

Sir/Madam,

I am to convey the decision of the 102nd Academic Council vide Resolution No:AC:102:2019:5:7:(i) held on 30th & 31st May 2019 which resolved grant of renewal of Provisional Affiliation for (i) BAMS (Bachelor of Ayurvedic Medicine & Surgery), and (ii) BHMS (Bachelor of Homoeopathic Medicine & Surgery) courses for a period of 3 (three) years w.e.f. academic sessions 2019-20 to 2021-22 in continuation to the Affiliation granted vide this office letter No.CDC/69/NEIAH/2011/-2055 dated 9/1/2019.

The Academic Council also resolved to increase the intake capacity of students from 50 to 60 since both the Colleges have adequate infrastructural facilities.

The College is required to fulfill the following conditions as laid down by the Inspection Team and report back to the University:

- 1) Efforts should be made to fill up the vacancies of Faculty positions, Medical Officers, Librarians and other supporting staff in both the Colleges and hospitals as per the CCIM & CCH norms.
- 2) The Director's Office cum administrative building should be made separately in the campus so that the library space will increase.
- 3) The bed occupancy should be increased in IPD in Ayurveda and Homoeopathy hospitals as per the CCIM & CCH norms.
- 4) In case of OPD, efforts should be made to increase the number of patients in some departments in both the hospitals.
- 5) Medicinal plants garden needs further improvement.
- 6) Pharmacy should be established in both the Colleges as per the CCIM & CCH norms.
- 7) High speed internet with good Wi-Fi Facility needs to be installed.
- 8) There is urgent need to create sports facilities and up-to date auditorium for cultural activities.


The fulfillment of the above conditions may be intimated to the undersigned at the earliest.


